Supplementary information to the notice of Telenor ASA's Annual General Meeting on 19 May 2026: Recommendation from the Nomination Committee regarding item 15

1. Recommendation from the Nomination Committee of Telenor ASA on the remuneration to the members elected by the shareholders to the Corporate Assembly and the Nomination Committee of Telenor ASA

Pursuant to Telenor ASA's Articles of Association article 9, Telenor ASA shall have a Nomination Committee. One of the Nomination Committee's tasks is to recommend to the Annual General Meeting the remuneration to the members and the deputy members of the Corporate Assembly and to the members of the Nomination Committee.

The remuneration to the members and deputy members of the Corporate Assembly and the members of the Nomination Committee was last adjusted by the Annual General Meeting on 21 May 2025.

2. Determination of remuneration to the Corporate Assembly of Telenor ASA

The Nomination Committee has, in its assessment of remuneration, among other things, considered the workload and responsibilities associated with the position as a member of the Corporate Assembly. Based on an overall assessment of relevant elements, the committee proposes to adjust the remuneration in line with general wage growth in Norway.
