Supplementary information to the notice of Telenor ASA's Annual General Meeting on 11 May 2020: Recommendation from the Nomination Committee regarding item 14

1 Recommendation from the Nomination Committee of Telenor ASA on the remuneration to the Corporate Assembly and the Nomination Committee of Telenor ASA

Pursuant to Telenor ASA's Articles of Association section 9, Telenor ASA shall have a Nomination Committee. One of the Nomination Committee's tasks is to recommend to the Annual General Meeting the remuneration to the members and the deputy members of the Corporate Assembly and to the members of the Nomination Committee.
